The bench, also comprising justices SK Kaul and KM Joseph, issued notice to the rights activists on a plea of the Maharashtra government, seeking their replies within two weeks, and stayed the operation of the high court order.

The bench considered the submissions of former attorney general and senior advocate Mukul Rohatgi, who appeared for the Maharashtra government, that denial of time would entitle the accused to statutory bail due to non-filing of the chargesheet within the stipulated time.

Assailing the high court order, Rohatgi, who was assisted by lawyer Nishant Katneshwar, said the investigating officer (IO) in the case had filed the application seeking extension of time for filing the chargesheet before the trial court and it was endorsed by the public prosecutor as well.
